Village Board Meeting Minutes March 17, 2025

Mayor Murphy opened the Village Board meeting at 5:30pm.

Privilege Of The Floor

David Radovanovic, tenant (neighbor) asked about a delivery to the sewer plant from the Honey wagon. Mayor explained it was a one-off need to have it disposed, a resident had an emergency. The Mayor made assurances that the back hauling was not starting up again.

The Vitali and wife Maria, residents inquiring on opening a dispensary in the Village. We are good businesspeople; we provide excellent customer service. We wanted to say hi and introduce ourselves. Mayor explained that dispensary would not be allowed in the Village near school, near churches, Boys and Girls club a lot of foot traffic for the children in the Village walking to Cahill School on Main Street. Mayor also explained within the Village parking is already an issue for current businesses. The potential would be the out skirts of the Village, that would be permissible.

Trustee Parisian asked to make a general comment, the total expense were up 7%, are we within the tax cap? Mayor stated we are 1.98%, we are under the 2% tax cap. The other big question, Sweeney carting went up \$10K? UCRRA pricing went up for commercial.

Joule Asset Community Power - Resolution # 2 for Extension for Extending the Joule contract through July 2025.

Trustee Parisian noted that Mobile Park will be coming to the Village Board Meeting on April 7, 2025, to do their presentation, answer questions. Mayor and Trustees have a discussion on fine tuning the permit process, areas of concern for parking.

Mayor Murphy brought up the Town and the Village shared service contract, that is a requirement now. The Mayor stated that the Shared Services Agreement can be approved for signing at the next Village Board Meeting, April 7, 2025.
