Dr. Daniel Erceg, Saugerties School Superintendent, discussion on the School Budget, voting date 5/21/2024 6AM – 9PM. Challenges from the budget this past year, 1.2 million coming back into the General Fund previously paid through our COVID funds. The COVID funds were spent on things that the district should have had over the years. \$1.4 million in terms of health insurance, \$500K increase in transportation costs. We are meeting this challenge with \$1.4 million in reductions, utilizing \$3 million fund balance, 4.9% tax levy increase.
