Planning Board Meeting and Public Hearings August 23, 2023

Chairman Mike Karashay opened the Planning Board Public Hearing and Meeting at 6:30pm.

<u>Public Hearing Struzzieri Properties LLC 310 Main Street Special Use Permit,</u> Mike Karashay requested if anyone was present to speak at the Public Hearing. Mike asked the residents to keep comments to five minutes. Please be respectful of the people in the room and respectful to the applicant.

Steve Yaeger – 44 ½ Partition Street, Village resident for about 35 years. I have attended the last two Planning Board meetings regarding the subject and there was no representation from Struzzieri Properties at either one. I did not address the Board at either one. When I left the meeting on July 12^{th,} I was standing in front of the building with other people who attended. I got a tap on my shoulder, and it was Tom Struzzieri; he asked to have a word with me and walked away and was clearly in an agitated state. He asked me what was going on here as if he didn't know, somehow knew to show up at that moment maybe his ears were ringing but more likely it was a cell phone. He asked me why I opposed this project? I said I think it's a bad idea for a few reasons, but mainly the Village would be stuck with it long after he sold it. He responded by throwing his arms up in disgust and poked his chest and said do you know what I do? He carried on and I let him talk. The last thing he said was I will get this through I have the Zoning, you can't stop me. It was very clear to me what this developer about this process and how he truly views this community. I know it would be wrong to deny this application because of that. In fact, you will have to decide this matter without any consideration for who he is, what he does or what he thinks. Listed as one of your duties as Planning Board members to ensure that any developments are following Zoning Code. The issue of the Special Use Permit is the only requirement for this project. This code exists for a very specific reason and is not just a formality. 310 Main Street is private property and is also a Village infrastructure. When a change like this is being proposed the code is invoked so the community can way in. Provides the community a measure of control over its future and means protecting itself from potential harmful impacts. Some of the impacts that are likely to occur if this project is approved are as follows: west bound traffic on Main Street attempting to turn left at this parking lot can be blocked by east bound traffic that is stopped at the red light when this occurs all traffic is blocked until the light changes. This problem will increase. Cars exiting the parking lot lined up on the intersection Jane Street and West Bridge Street, this intersection is already problematic. Often cars parked on West Bridge Street make it difficult to see, cars often exceed the 25MPH speed limit on West Bridge Street. There are two curb cuts at the Medical facility and very busy place at times. Several driveways within 200 feet of that intersection. To top it off, that location is a bus stop for public transportation. It's fair to say that the problems that occur there will increase. That means more honking horns, more screeching tires and more people shouting at each other. Also, at the hotel itself

there are likely to be more calls for emergency services. In other words, more sirens, and lights in the middle of the night and probably more car alarms sounding. These are all things that diminish the quality of life and public safety for the people who live around it. I would also like to point out the parking lot plan is insufficient. It shows no change for the current configuration. I think it should be reviewed by independent engineer to determine if it meets present day standards for traffic flow and public safety. It is not grandfathered in for use as a hotel parking lot. Also listed as one of your duties is to ensure the development is in accordance with the goals set forth by the Comprehensive Plan. This document depicts the future of Saugerties that grows and prosperous in a way that maintains our small-town character and all the things we cherish about living here. In order to achieve that we need to make wise choices with our infrastructure. Our small-town character is our greatest asset and the reason most people find it desirable to live here. If we let it slip away it for the benefit of a few it will be gone forever. I think this proposal is a step in the wrong direction and could very well be a turning point. It's a bad fit for the people who will live around it and the community as a whole. Calling this a hotel and registering as such is nothing more than a way to get around the Air BnB regulations that are sure to come. Allowing this to go through opens the door for others to do the same thing. If this Board can't see that or if this Board can see it and still do nothing about it; then there is no point to this process or the Comprehensive Plan. We should just stop pretending because it's all a waste of time. I am asking that you see this proposal for what it is and not who it is. It's seven room short term lodging facility unstaffed and unsupervised. There are no provisions for public safety for either inside or out, please look at this as if it was to be right next to your home. Picture in the future as the building ages and changes ownership. There are other options for this property that would be more appropriate for our community. If no other options are suitable for this owner, he should sell it. The records show that the property was purchased from Town of Saugerties in 2002 for \$125K, selling it would not be an undo burden. Please protect this community, send a message to investors that their plans need to be more community oriented and reject this application.

Jackie Russell – 11 West Bridge Street – see attached letter dated 8/23/2023 that was read at the 8/23/2023 Planning Board Meeting.

Rosemary Stickley – 402 Manorville Road – I would like to wholeheartedly endorse the comments opposing the special use permit in addition to the excellent points made regarding this project. A contactless unstaffed hotel will not provide jobs although will require Village services and create a burden on our tax dollars. There is no net win for the community, the only person who benefits is the owner.

Marjorie Leopold – 5 Highwoods Road – I also endorse the comments of the three people who preceded me. I am also speaking as the co-coordinator for the Saugerties Smart Housing Town Task Force. We had a presentation recently by Adam Bosch of Pattern for Progress; he pointed out that a community that is depending on a very large part on tourism is a sort of hollowed-out community. People who have other businesses and other jobs can't afford to live here. Children can't afford to come back here. Catering to people who are coming in and stores are pricing goods for too expensive for residences to purchase and they are closed half the time, the Village looks like a ghost town sometimes in the middle of the week. A thriving community is where workers and middle-class people can shop and enjoy a meal. Tourism comes and goes, it's here today and gone tomorrow as we know from the Catskills from 2008. While Diamond Mills and HITS have added to Saugerties, to extend many rooms in an unmanaged hotel is probably not very wise. I support the other comments. I would hope that property could be sold as used for permanent apartments.

Sean Grim – 11 West Bridge Street – My wife and I live next to proposed development. I would like to support the comments that those who spoke. The short-term transient nature of this is not in the long-term interest of the Village. Several hundred people agree with me. This process of public comment and think it's a bad idea.

Rae Stang makes a motion to close the Public Hearing for Struzzieri Properties LLC 310 Main Street Special Use Permit. Bill Barr seconds the motion to close the Public Hearing for Struzzieri Properties LLC 310 Main Street Special Use Permit. All in favor. The motion carried.

Mike Karashay – explained that now closing the Public Hearing the Planning Board has 62 Days to vote on the application for Struzzieri Properties LLC 310 Main Street.

<u>Public Hearing 105-107 Partition Street LLC Special Use Permit –</u> No residents signed up to speak at the Public Hearing for 105-107 Partition Street LLC.

Jackie Russell – I don't understand the process, how will we be informed of the voting process?

Ben Neidl explained 62 Days vote in a Public Session, where the public can observe the voting process during a regular session of a Planning Board Meeting.

REGULAR MEETING

Mike Karashay explained the process of approving the minutes of the Planning Board Meeting minutes, the minutes are sent out for review, the Planning Board members will review and approve at the next Planning Board Meeting and then are posted for the public.

Mike Karashay presented the meeting minutes from the July 12, 2023, Planning Board meeting. Bill Barr made a motion to approve the meeting minutes from the July 12, 2023, Planning Board meeting. <u>105-107 Partition Street -</u> Mike Karashay read UCPB response, please attached.

Mike Karashay – asked the if applicant to agree with the required modification, the applicant stated that not their intention for short term rental, need flexibility if it is needed.

Requirements need a super majority to vote. Need to wait until there is a full board, which the chair and the clerk will communicate that there are enough board members to vote.

Chris Coleman request of the Board for any questions of the Planning Board to be answered now. Bill Barr said there is a housing crisis caused by short term rentals, and I would like to do anything I can to make housing

affordable. Chris responded that this project is creating housing where there is none. The other project is transferring long term housing to short term rental (STR). It's critical distinction.

Bill Barr – Saugerties hasn't had a housing crisis that we are currently under. We can't expect what's always happened in the past to be the same in the future.

Rae Stang – I think everybody gets confused with housing and affordable, we asked you before you are in it for the profit.

Scott Roebert – explained that these are reasonable sizes and will be affordable.

Rae Stang – what we need is affordable but need housing.

Scott Roebert – there are no open lots to build in the Village. These could be people that could work and live in the Village.

Chris – explained that we have four apartments, when the leases are set up and rents get paid, can't agree to a condition with a tight a margin and not have options if there is an event that occurs to restrict the option of a STR. Mike Karashay stated that a super majority voted to override the recommendations. Chris stated that the Village has there own zoning and their codes.

Discussion on 310 Main Street

Mike Karashay – read Ulster County response on Struzzieri Properties 310 Main Street, see attached

Rae Stang – a lot of people brought up the Comprehensive Plan,

Mike Karashay – Comprehensive Plan is a guide, and a suggestion is not a law; the Comprehensive Plan is a guide. Until the Zoning Laws can be amended to include what the recommendations of the Comprehensive Plan. We should consider parts of the Comprehensive Plan. It becomes a gray area; the deliberation is it within the statue of the Village of Saugerties to have a hotel in that space with a special use. By the way it could be an Air BnB without a special use permit and no discussion with the public. Rae- if this is denied then he could do an Air BnB without a public hearing, he could do what he wants. Mike Karashay – no what is permitted by Zoning, the restaurant, not fast food, commercial retail facility, Air BnB, boarding house the reason the Public is here the applicant is seeking a special use. Parking in area, the property is private, and the parking spaces are private.

Bill Barr- A developer and property owner have the right to charge whatever the market will allow. This requires a special use permit, decisions, and findings. Under the proposed use character that will be in harmony with the appropriate orderly development of the district. I don't see allowing short term rental as promoting that.

Ben Neidl - the application is for a hotel, be careful using the definition using short term rental.

Eyal Saad – May contain, not must contain, if you choose to have it you can. Short-term rentals are coming fast and quickly.

Bill Barr – Based on the Comprehensive Plan, I would vote against approving the application

Ben Neidl - Hotel under your code is a special use for this zone. If the Village Board Trustees makes something use for this Zone, the legislative has decided this for you. The Planning Board should be deciding on site specific. Anyone can petition the Village Board of Trustees to change the law, that has not happened.

Bill Barr – thank you for the explanation

Rae Stang – a lot of people are against this for some reason, do we take that into account somehow?

Ben Neidl – There is a principal of the law that generalized community objection is not a reason to deny something. The Public might offer something like a traffic study. People have their right to their opinion and their 1st amendment to speak.

Mike Karashay – the Planning Board can make a requirement of the applicant, to remove some of the concerns from the public. The input received from is important from the public. Unfortunately, we do not have a full Planning Board tonight and we will need to hear input from the rest of the Board.

Mike Karashay made a motion to table the conversation of Struzzieri Properties 310 Main Street for next meeting. Rae Stang seconded the motion to table the conversation of Struzzieri Properties 310 Main Street for next meeting. All in Favor. The motion carried unanimously.

Mike Karashay made a motion to adjourn the Planning Board meeting. The motion to adjourn the Planning Board was seconded by Bill Barr. All in Favor. The motion carried unanimously. The meeting adjourned at 7:30pm.

Recommendations

Defining Hotels – Advisory Comment

As an existing structure with no external changes proposed, the project in and of itself does not rise to the level of county impact as an individual site. However, the Village's definition of a hotel currently reads:

"A building, or any part thereof, which contains living and sleeping accommodations for transient occupancy, has a common exterior entrance or entrances, and may contain one or more common dining rooms, drinking places and entertainment facilities."

Given the above definition, there is nothing within it that requires there be an on-site reception or on-site check-in with full-time staffing on the premises. The UCPB recommends that the Village, to avoid the potential proliferation of satellite-style hotels that operate similarly to vacation rentals, include requirements that require these facilities to be an independent facility, especially if not at the same time or not adjacent to other buildings associated with the hotel at large, and provides guests with full access to services as part of the defined requirements for being a hotel or motel.

Dear Planning Board Members:

Multiple times when looking for information concerning this and similar project proposals, I have been referred to the minutes of the meeting. How are residents supposed to stay informed when the minutes are not posted to the website in a timely fashion? The very introduction of our Comprehensive Plan stresses "citizen involvement" and "supporting growth that is compatible with community standards." Again, how can this happen when the community is kept in the dark?

At the June 14 meeting, Mr. Neidl specified that 310 Main Street is zoned B1; while a hotel is an appropriate use for this property, a Special Use Permit would still be necessary. This would require approval by the Planning Board whose duties include ensuring that proposed development is in accordance with the goals outlined in the Comprehensive Plan. As described on the Town/ Village website, the goals of the Plan include:

- ~7.14 Amend the Town/Village Zoning laws to regulate short-term rentals in order to mitigate potential impacts to neighbors and protect the public health, safety, and welfare.
- ~13.2 Tourism is an important business in the Saugerties area. The Town and Village believe that it should be an important, but not the sole, element of economic development strategy for the communities.
- ~13.4 Tourist attractions, located within Saugerties, must benefit the community through adding jobs and/or additional patronage of the community businesses and mitigate potential negative impacts such as additional traffic, parking, and pollution.

In addition, ArticleXIII, section 210-59 B of the Village Zoning Code for the issuance of Special Use Permits states :

"In reviewing site plans, consideration shall be given to the public health, safety, and welfare; the comfort and convenience of the public in general, or the residents or users of the proposed development and of the immediate neighborhood in particular..."

In recent years, there has been a lot of development in the Village center. I feel that the aggregate effect of this development, along with new projects, needs to be considered, as well. When viewed together their impact is dramatically different than individually.

I request that the Village Planning Board deny this Special Use Permit because it is not in accordance with the Comprehensive Plan and zoning guidelines as described above.

I am submitting a petition from the community with signatures collected through both paper and online versions, including testimony from the neighbors within the immediate vicinity of this property as well as the wider Saugerties community. The signatories feel that our safety and quality of life would be compromised by the proposed use of this property. The project neither aligns with the Saugerties Comprehensive Plan, nor is it in the best interest of the community.

Inarguably, HITS and Diamond Mills have been an economic boon for Saugerties, and we are fortunate to have them. They have helped make our village an active hub. The community and leadership have been welcoming and supportive, and as a result, Mr. Struzzieri has been able to enjoy considerable success. But an applicant should not be granted a Special Use Permit based on business activities or philanthropy, especially when it threatens the quality of life of Saugerties residents.

I sincerely hope that, as a community, we will be able to support an alternative use for this property that suits the needs of the residents while allowing the developer to profit. But the current proposal is one-sided in its aims.



The Village of Saugerties Planning Board is currently reviewing an application for the Commercial Site Plan and Special Use Permit for 310 Main Street to **change the use from an office building to hotel occupancy**. The plan seeks to use the existing footprint of the structure and renovate the interior to accommodate 7 units. **It is designed to operate without supervision in the heart of the Village.**

There are a number of concerns regarding this proposal, particularly it's promotion of an unknown transient population.
